### PROGRAM RESTRICTIONS

\*Rental qualifications for 18-20 year old include but are not limited to proof of full collision, comprehensive and liability insurance that transfers to a rental vehicle. Underage surcharge of \$7/rental will be assessed.

- Member is responsible for returning the vehicle on time. Late returns will be assessed a fee of \$25 plus additional hourly rental charges.
- Member is responsible for returning the vehicle clean and ready for the next Member.
- All vehicles are non-smoking. If smoking occurs, a fee of \$75 will be assessed.
- Member is responsible for damage to vehicle. Check your auto policy and/or credit card agreement for rental vehicle coverage. Optional Collision Damage Waiver is available for purchase. This optional coverage will be selected on the Enrollment Agreement and each rental will conform to this decision. This option may only be changed upon submission of a new Enrollment Agreement.
- Enrollment Agreement must be submitted annually.
- Individual Member is the only person authorized to rent vehicle. A spouse may drive the vehicle once rented. Spouse may not rent without Member present.
- Citations such as parking or moving violations are the responsibility of the renter.

### ENROLLMENT PROCESS

- Fill out and submit Enrollment Agreement. Mail original to 360 Oak Road, Stanford, CA 94305. Fax will be accepted to begin the process. Fax to 650-833-8064.
- Allow 14 days to verify Stanford residency, current driver's license and insurance information.
- A Welcome Packet will be sent when Membership is activated.

*\*Terms and Conditions: Offer valid for vehicles reserved in advance. Vehicles include 4 cylinders and a/c. Discount does not apply to taxes, fuel, or optional products and services including but not limited to Collision Damage Waiver. ### ONE-SIGNATURE RENTAL PROCESS

After my Enrollment Agreement is processed, I understand that I must book reservations in advance. I understand that vehicles are subject to availability. As a condition of each rental, I will meet normal driver qualifications (i.e. minimum age, valid driver's license, major credit card). As a special accommodation, I will be required to sign only one line of the Rental Contract each time I rent a vehicle. In turn, I agree that the terms and conditions of the Rental Contract will apply to the rental, and are incorporated into this Agreement by this reference. In addition, I agree that my spouse and/or I are the only drivers of the rental vehicle. I also agree to notify Enterprise of: (1) any suspension, withdrawal or expiration of my driver license, (2) any change in Stanford residency, (3) any change in contact or credit card information, (4) any change in insurance carrier or coverage, or (5) physical loss of drivers license.
